## Texas Prepaid Higher Education Tuition Program Contract Downgrade Form

To downgrade a *Texas Guaranteed Tuition Plan* contract, the Purchaser and Joint Purchaser, if applicable, must complete and return a signed and notarized Contract Downgrade Form to the Texas Guaranteed Tuition Plan, P.O. Box 13407, Austin, TX 78711, or FAX it to (512) 475-0081. The \$50 downgrade fee will be deducted from the proceeds. If the proceeds are not sufficient to pay the fee, we will notify you.

Please note that your account can only be downgraded to a plan type with lesser benefits. Information on downgrading your account is available at [www.tgtp.org](http://www.tgtp.org). Your request will be processed within 30 days of receipt in our office of your completed and notarized form. You will receive a letter from our office confirming the downgrade after your request is processed. If the result of the downgrade is that your plan is paid in full with excess funds available, a refund will automatically be sent payable to the Purchaser and Joint Purchaser, if applicable. **Once downgraded, an account cannot be restored to its former status.**
